Cabinet meeting held at the Ambasciata d'Aragona, Valletta, on Wednesday, 30th October, 1963, at 10.30 am.

The minutes of meeting No. 46/63 were read and confirmed.

Wheat supplies to Malta (Memo. No. 202).

Arising out of the minutes of meeting No. 46/63, the Hon. Minister of Industrial Developments & Tourism informed the Cabinet that necessary action had been taken to stockpile wheat as far as all available storage space permitted.

Request for additional land at Kewkija, Sogo, by the Sogo Milk & Agricultural Producers Co-operative Society Limited (Memo. No. 203).

It was explained that in 1959 the Society was granted on perpetual emphyteusis a plot of land at Kewkija, Sogo, for industrial purposes. The Society now asked for the grant of further land to expand their industrial activities, to rectify certain faults in the present structure and to install and run a Petrol Station.

It was felt that the additional land asked for was essential for the purposes it was required. The Tribunal therefore agreed that it be granted to the Society on perpetual emphyteusis on condition that the grant would be dissolved should the Society cease to exist. Before any further action was taken the Hon. Minister of Agriculture, Power & Communications and the Hon. Minister of Justice were to discuss the matter further and inform the Sogo representatives in the Legislative Assembly.

Confirmation of written opinion.

Land 1342/63. H.E. the Governor was advised to sign Declaration for the acquisition of premises at Paola, which were scheduled for demolition.

Land 500/62. H.E. the Governor was advised to sign Declaration for the acquisition of premises at hosts required for the construction of the hosts Civic Centre.

Land 816/62. H.E. the Governor was advised to sign Declaration for the acquisition of land at Birkirkara required in connection with the opening of a street.

Land 1286/63. H.E. the Governor was advised to sign Declaration for the acquisition of land at Kewich required for the erection of a factory.

M.O.J. 83/62. H.E. the Governor was advised to approve arrangements regarding the duties of Her Majesty's Judges.
