Appointments of Rotary Public: General Authority to the Prime Minister.

Ministers agreed that the Hon. Prime Minister be given general authority to advise H.E. the Governor General on appointments of Rotary Public direct, without the necessity of consulting the Cabinet as a whole.

Conversion of flats into hotels.

Ministers considered the current housing shortage in Malta and Sgo and agreed that the problem would be alleviated if property owners were discouraged from converting flats into hotels. It was therefore ~~agreed~~ decided that the conversion of flats into hotels should in future be permitted only with the approval of the Cabinet.

Acquisition of land at Kalaparna and Birgħajja limits of Birgħajja.

Ministers agreed that H.C. the Governor General be advised to sign Declaration for the acquisition of sixty-one plots of land at Kalaparna and Birgħajja limits of Birgħajja, which were required by the Government in connection with the ~~Love~~ Park Project.
