MEMORANDUM BY THE MINISTER OF JUSTICE AND PARLIAMENTARY
AFFAIRS

Land Acquisition (Public Purposes) Ordinance (Cap. 136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of 15 plots of land at "ta l-Inglis", in the limits of Msierah.

Since this land is permanently required by the Government, it is proposed to acquire it by absolute purchase.

The said land is required by the Government for the extension of the Msierah Industrial Estate; it is therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance, Chapter 136.

From the report by the Land Engineer it transpires that the total freehold value of the above 15 plots of land amounts to £4,658. 0s. 0d.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the Land

The following land at "ta' l-Inglis", limits of Msierah:-

1. A plot of land of the area of 1 Tumolo, 2 Sieghan and 6.64 Kejliet, bounded on the North-East and on the South-East by property of the Parish Church of Birkirkara, on the North-West by an alley and on the South-West by the remaining portion of the land of which such plot forms part; it is the property of Mr Vincent Camilleri.

2. A plot of land of the area of 7 Tumoli, 5 Sieghan and 4 Kejliet, bounded on the North-West and on the West partly by property of Mr Vincent Camilleri and partly by an alley, and on the East partly by property of the Parish Church of Balzan in course of acquisition by Government and partly by property of the Parish Church of Birkirkara in the course of acquisition by Government; it is the property of the Parish Church of Birkirkara.

3. A plot of land of the area of 2 Tumoli, 1 Siegh and 4 Kejliet bounded on the South-East by an alley, on the North-East by property of Miss Helen Grech and others, and on the West by the remaining portion of the land of which such plot forms part; it is the property of Mr Anthony Sciberras.

4. A plot of land of the area of 5 Sieghan and 4 kejliet, bounded on the South-West partly by property of Mr Anthony Sciberras and partly by an alley, on the East by property of Mr Carmelo Borg and on the North by the remaining portion of the land of which such plot forms part; it is the property of Miss Helen Grech and others.

5. A plot of land of the area of 5 Sieghan, bounded on the West by property of Miss Helen Grech and others, on the South-East and on the South West by an alley, and on the North by the remaining portion od the land of which such plot forms part; it is the property of Mr Carmelo Borg.

6. A plot of land of the area of 2 Tumoli, 1 Siegh and 2 Kejliet, bounded on the South and on the South-East by property of Captain Bernard Sant Cassia and others in the course of acquisition by Government, and on the North-East by property of the heirs of Mr Vincent Pisani; it is the property of the Church of Saint Paul's Shipwreck of Valletta.

7. A plot of land of the area of 2 Sieghan and 8 Kejliet, bounded on the South-West by property of the Church of Saint Paul's Shipwreck of Valletta, on the South by property of Captain Bernard Sant Cassia and others in the course of acquisiton by Government and on the East by property of Mr Joseph Zarb; it is the property of the heirs of Mr Vincent Pisani.

8. A plot of land of the area of 1 Tumolo, 2 Sieghan and 2 Kejliet, bounded on the West by property of the heirs of Mr Vincent Pisani, on the South by property of Captain Bernard Sant Cassia and others in the course of acquisition by Government and on the South-East by an alley; it is the property of Mr Joseph Zarb.

9. A plot of land of the area of 2 Tumoli and 1 Siegh, bounded on the North-West by an alley, on the South-West by property of Captain Bernard Saint Cassia and others in the course of acquisition by Government and on the North-East partly by property of Mr Emmanuel Aquilina and partly by property of Mr Emmanuel Galea; it is the property of Mrs Helen Vassallo.

10. A plot of land of the area of 1 Tumolo, 4 Sieghan and 3.7 Kejliet, bounded on the South-West partly by an alley and partly by property of Mrs Helen Vassallo, on the South by property of Mr Emmanuel Galea and on the East by property of Mr Joseph Briffa and others; it is the property of Mr Emmanuel Aquilina.

11. A plot of land of the area of 1 Tumolo, 1 Siegh and 3 Kejliet, bounded on the South-West by property of Mrs Helen Vassallo, on the North by property of Mr Emmanuel Aquilina and on the East by property of Mr Joseph Briffa and others; it is the property of Mr Emmanuel Galea.

12. A plot of land of the area of 4 Sieghan and 5.4 Kejliet, bounded on the East by property of Mr Joseph Dingli, on the North by property of Mrs Helen Vassallo and on the South by property of Notary Joseph Gatt LL.D., it is the property of Mrs Carmela Sciberras.

13. A plot of land of the area of 5 Sieghan and 2 Kejliet, bounded on the West by property of Mrs Maddalena Vella in the course of acquisition by Government, on the North by property of Mrs Carmela Sciberras and on the East by property of Mr Joseph Dingli; it is the property of Notary Joseph Gatt LL.D.

14. A plot of land of the area of 2 Tumoli, 2 Sieghan and 2.6 Kejliet, bounded on the West partly by property of Mr Emmanuel Aquilina and partly by property of Mr Emmanuel Galea, and on the South by property of Mr Joseph Dingli and on the North by property of Mr Joseph Aquilina; it is the property of Mr Joseph Briffa and others.

15. A plot of land of the area of 6 Tumoli, 5 Sieghan and 7 Kejliet, bounded on the North by property of Mr Joseph Briffa and others, on the West partly by property of Notary Joseph Gatt LL.D. and partly by property of Mrs Carmela Sciberras and on the South partly by property of Mrs Helen Grech and others in the course of acquisition by Government and partly by property of Mr Gio Batta Grach; it is the property of Mr Joseph Dingli.

The abovementioned land is shown on a plan marked L.D. 43/67, which may be seen on demand at the Land Office, 29, South Street, Valletta.
