Land Acquisition (Public Purposes) Ordinance (Cap.136)

The attached Declaration by His Excellency the Governor-General refers to the release of nine (9) plots of land at Zebbug, Malta.

The nine (9) plots of land in question had been declared to be required for a public purpose by the competent authority by means of a Declaration signed by His Excellency the Governor-General on the 19th January, 1971, and published by Government Notice No. 109 of the 29th January, 1971.

As the said nine (9) plots of land are no longer so required by the competent authority, the attached Declaration is intended for their release.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

Whereas by declaration dated the 19th January, 1971, published in the Government Gazette of the 29th January, 1971 under Notice No. 109, His Excellency the Governor-General had declared, the undermentioned land to be required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and whereas the undermentioned land is no longer so required, I hereby declare for all intents and purposes of law, that the undermentioned land is no longer required by the competent authority for a public purpose in accordance with the provisions of the aforementioned Ordinance.

----- Description of the Land -----

The following land at Zebbug, Malta:--

1. A plot of land of the area of 147.6 square canes, bounded on the East and West by property of Reverend Joseph Galea, and on the North-North-East by a public road.
2. A plot of land of the area of 66.7 square canes, bounded on the West by property of Reverend Joseph Galea, and on the South and East by a public road.
3. A plot of land of the area of 93.1 square canes, bounded on the West and East by property of Mr. Salvatore Vassallo, and on the North-North-East by a public road.
4. A plot of land of the area of 121.1 square canes, bounded on the West and East by property of Mr. Gaudenz Magro, and on the South-South-West by a public road.
5. A plot of land of the area of 127 square canes, bounded on the West and East by property of Mr. Gaudenz Magro, and on the South-South-West by a public road.
6. A plot of land of the area of 71.9 square canes bounded on the West and East by property of Mr. Carmelo Agius and on the North-North-East by a public road.

7. A plot of land of the area of 94.2 square canes, bounded on the West and East by property of Mr. Carmelo Agius and on the North-North-East by a public road.

8. A plot of land of the area of 118 square canes, bounded on the West and South by property of Mrs. Miriam Muscat, and on the East by Government property.

9. A plot of land of the area of 99 square canes, bounded on the East and South by property of Mrs. Miriam Muscat, and on the West by Government property.

The abovementioned land is shown on plan marked L.D. 186A/70, which may be seen on demand at the Land Office, 29 South Street, Valletta.
